International students still recommend the UK (14 July)

In spite of Brexit, the UK is still a desirable study destination for international students.

A new 2017 study, <u>published by Universities UK International</u>, <u>The UK's Competitive Advantage</u>, found that international students in the UK have higher levels of satisfaction than their global peers.

The study revealed that 86 percent of international undergraduates in the UK are "very likely" to recommend the UK as a study destination. This figure is three percentage points higher than results in 2008.


Applications to British universities fall 4% overall (17 July)

- This includes a 5% decline in applications from EU students, a drop that overshadows a 2% increase in applicants from non-EU countries

Survey reveals most international students confused by UK's TEF (21 July)

Just one in five prospective international students have heard of the UK's Teaching Excellence Framework and of those who have, almost 80% incorrectly believe it measures the teaching quality of both undergraduate and postgraduate courses.

HEFCE introduced the voluntary scheme in 2016 to recognise quality in teaching at the undergraduate level. Last month the first round of Gold, Silver and Bronze ratings were <u>awarded to some surprise from</u> the sector as many of the country's highly ranked institutions missed out on top tier results.

United States resumes fast processing of some H-1B visa categories (25 July)

The US has announced resuming faster processing of H-1B work visas, popular with Indian techies, for high skilled foreign professionals in categories exempt from Congress-mandated limit, which are mostly for higher education and scientific research institutions.

The H1-B visa is a non-immigrant visa that allows US companies to employ foreign workers in speciality occupations that require theoretical or technical expertise in specialised fields. The technology companies depend on it to hire tens of thousands of employees each year.



Modest growth in Australia's ELICOS numbers masks revenue windfall (25 July)

Australia's ELICOS sector continued its steady growth in 2016, reaching new heights for student numbers, weeks and revenue metrics, according to the latest market report by English Australia.

The report found student numbers, total student weeks and economic impact all surpassed 2015 national records, while average course length bounced back after a minor decline last year, to also surpass its previous record.

While student numbers experienced a relatively modest 2% growth to reach 173,506, student weeks and economic impact both registered strong increases of 10% (2,319,175) and 8% respectively. The latest figures value the sector at A\$2.258bn.
